

## AFTER 30 HOURS OF CLASSROOM, WHAT HAPPENS NEXT?

### GETTING A PERMIT:

#### ON THE FIRST BUSINESS DAY AFTER LAST DAY OF CLASS:

Student is able to get his/her permit, IF STUDENT IS ALREADY 15.

If Student is not yet 15, he/she can get permit after turning 15.

#### PERMIT MUST BE OBTAINED FROM THE DMV WITHIN 180 DAYS FROM THE DATE OF THE LAST DAY OF CLASS.

If Student passes the 180 day mark, class will have to be retaken for a fee of \$100.00.

#### **STUDENT PROVIDED DMV WITH INFORMATION TO GET A PRE-REGISTRATION CODE (effective June 2018).**

**DMV has been provided with Student name and birthdate which is proof Student completed the Drivers' Ed class. DMV emailed return receipt and an attachment entitled "Third Party Exam Completion." PRINT IT AND TAKE TO THE DMV to get permit.**

#### **Other steps to take to get a permit:**

1. You must be 15 years of age or older.
2. You must present 2 FORMS OF IDENTIFICATION-- ORIGINAL BIRTH CERTIFICATE AND ORIGINAL SOCIAL SECURITY CARD.
3. You must pass the written permit test.
4. Parent must present the AFFIDAVIT OF LIABILITY-IT MUST BE SIGNED AT THE DMV. This form is in both the manual and workbook you received in class.
5. You must provide 2 forms of Colorado residency.

### 6 HOURS OF STREET DRIVING:

On the first day of class, Student completed an informational card which is then given to a CCSD Drivers' Ed Driver. Student will get name of Driver either being told name and phone number on the last day of class or within one month from the end of class, **DRIVER WILL REACH OUT TO STUDENT** (via phone, text or e mail), introducing him/herself and asking Student to get in touch when they would like to start the 6 hours of street driving. **STUDENT SHOULD RETAIN NAME AND PHONE NUMBER OF DRIVER** (it can be written at bottom of this sheet). **REMINDER:** Street driving cannot commence until Student has a permit. Parent and Student should confer as to what dates are best for the street driving and **Student** should contact Driver to set up dates/times and meeting place (driving is in CCSD vehicle). If contact information is lost, please contact Drivers' Ed office (720-554-4343; [ccsddriversed@cherrycreekschools.org](mailto:ccsddriversed@cherrycreekschools.org)). Once driving days/times are confirmed, Student needs to honor his/her commitment; however, if changes need to be made, Driver should be contacted directly to reschedule. When 6 hours with Driver is completed, Driver will log into DMV website and record days he/she has driven Student. Student is strongly encouraged to complete 6 hours of street driving within 2 years of getting permit.

It is recommended that Student drive a few hours with Parent before he/she drives with Driver so the 6 hours can be spent improving skills and doing around the town or freeway driving. However, if Parent and Student would prefer Student drive with Driver immediately, Student should contact Driver.

**At the conclusion of the street driving, Student will receive a card documenting the street driving to be given to his/her insurance company once Student obtains a driver's license. KEEP THIS CARD IN A SAFE PLACE.**
